Due to the length of time paperwork can take to complete AHC forms we now require that clients complete and return this form 5 days prior to appointment. Please complete in full **block capital letters or type** and return or email completed form to your branch email noted above.

If we do not receive this information we reserve the right to not proceed with your appointment and may need to cancel it.

The information must be accurate, if not the AHC may not be correct and you may be refused entry to the EU at the border control. It is your responsibility to ensure the information entered is correct. Please phone your branch should you need clarification on any of the questions.
